**RE: Victims Group affidavits**

This follows our discussion last week about the supplementary affidavits sworn by several members of the Victims Group, pursuant to the order of the Commissioner made on April 26, 2007.

We confirm that we have provided the Commission with original sworn copies of 22 supplementary affidavits. Below is a brief summary of the corrections outlined in these affidavits, for your ease of reference. Specific reference to the inaccurate paragraphs in the original affidavits is made in the supplementary affidavits. Supplemental affidavits have been sworn by:



C-115

Did not report his abuse to the police and did not engage in the criminal process.

Cindy Burgess-Lebrun

Dealt with the OPP, not the "Cornwall police."

Pursuant to orders by the Commissioner dated February 20, 2007, October 12, 2007, December 3, 2008 and January 28, 2009 granting publication bans, pages 1 to 4 of this letter have been edited.

Scott Burgess

Did not drop out of school after Grade 9. He completed high school.

[REDACTED] C10

Originally identified Father Charles MacDonald and Father Gilles Deslauriers as perpetrators of abuse, but was not abused by either. He did not initiate an action against the Diocese.

Andre Gauthier

Error in the spelling of Father Francois Lefebvre's last name. Dealt with the OPP, not the "Cornwall police."

[REDACTED] C-119

Was not exposed to alcohol at St Joseph's. Did not turn to drugs to deal with the abuse. Was abused by a Catholic Brother, not a priest. Did not report abuse to any institution. Statements that counseling support was an out-of-pocket expense that he could not afford, that he required counseling, and that he cannot maintain gainful employment are all false.

[REDACTED] C-120

[REDACTED] clarifies that he was abused by Ken Seguin while a probationer, but that Mr. Seguin was not his assigned probation officer. As such, the statement that he was abused by a "person entrusted with my counseling and rehabilitation", could be misleading, although he does believe that Mr. Seguin had authority over him in that situation. Did not report abuse to the police and did not engage in the criminal process.

Stuart Labelle

Not diagnosed with Multiple Personality Disorder. Income set out was from employment, not disability benefits.

[REDACTED] C-121

Abuse lasted 4-5 months, not one year. Did not report abuse to the police and did not engage in the criminal process.

[REDACTED] C-123

Error in spelling, "Hood" should be "Houde." He dealt with the Alexandria Police, not the "Cornwall police."

[REDACTED] C-124

Did not report abuse to the police and did not engage in the criminal process.

[REDACTED] C-125

Was not "in" an institution at the time of the abuse, but rather was under the control of Probation services. He was not exposed to alcohol at this time. Did not report abuse to the police and did not engage in the criminal process.

[REDACTED] C-127

Did not report abuse to the police and did not engage in the criminal process.

[REDACTED] C-105

St. Joseph's Training School should be "St. Joseph's elementary school in Alexandria, ON"

[REDACTED] C-17

Dealt with the OPP, not the "Cornwall police."

Robert Renshaw

He was not raised in a devoutly Catholic family. Dealt with the OPP, not the "Cornwall police."

G.R.

Did not report abuse to the police and did not engage in the criminal process.

[REDACTED] C-131

Perpetrators should not be plural. Statement that that many claims of abuse were not investigated, as it relates to her specific situation, is false. She went to the police with one complaint and it was investigated.



C-132

Statement that he was not offered psychological counseling or support by Diocese to be removed as he did not ask for help from the Diocese.

Adrien St. Louis

Did not report abuse to the police and did not engage in the criminal process.

Fernand Vivarais

He had not reported his abuse to the police at the time he swore the original affidavit, and he had not yet engaged in the criminal process.

Rejean Vivarais

Did not report abuse to the police and did not engage in the criminal process.

Please also be advised that we have been unable to contact five of the original affiants for the purposes of verifying the accuracy of their affidavits. The first is our former client Ron Leroux. As you know, Mr. Leroux terminated his retainer with our firm prior to this affidavit issue being raised. He is now represented by David Williams at Harrison Pensa in London, Ontario. We wrote to Mr. Williams on April 30, 2007, enclosing a copy of Mr. Leroux's original affidavit, two copies of draft supplementary affidavits for his reference, and a description of the Commissioner's order. We advised Mr. Williams that he should contact Commission counsel directly in relation to this matter.

We have made repeated efforts to reach four other affiants with no success. Each of these men was sent several letters and we made repeated attempts to reach each by telephone. We have not received a response from any of them at any time since this issue arose. Their original affidavits have not been reviewed with them. With respect to two of these men, we no longer have any contact information for them whatsoever. We are in a position of simply having to wait to see if they contact us. 



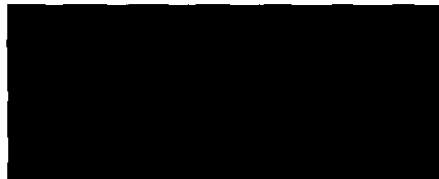

to be true and, as such, that sentence should be removed.

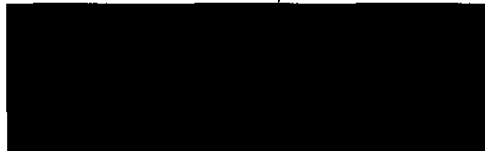
