Dear Honourable Michael Bryant:

Last month, you, Ontario Attorney General Michael Bryant, supported by assertions from a list of credible personalities, assured the world, that the Judge/Commissioner appointed to lead the public inquiry, had no roots or connections to Cornwall and Area. However, recently, it has been discovered that Judge Normand Glaude has deep roots and connections to the Cornwall Area. So, how does Judge Glaude handle being confronted with the new discoveries? Judge Glaude states in part that if people have any concerns, then, when the hearing is started and an office is set up, people can voice their concerns and they will be recorded. WHAT! WHEN IT'S STARTED!! NO WAY, JUDGE GLAUDE MUST NOT LEAD THE INQUIRY!!

How dare anyone speak out!! To me, the statement by Judge Glaude is, arrogant and dismissive. I interpret this as another example of the autocratic, “ruling class”, mentality, ... which is never opposed, rarely held to accountability, while attempting to instill, “silence, power, obedience and fear” into others. Judge Glaude tries to “take order”. The powerful and demeaning implication projected by Judge Normand Glaude is, “Be silent. I know better.” This is yet another, in a long line of, misrepresentations, officials have spun, in an effort to lull Cornwall citizens into a false sense of security. This is another example of why citizen's do not have faith in the “system”, as far as “Project Truth and related” is concerned. How dare anyone, confront officials; how dare anyone question Judge Glaude's credibility surrounding his “lead”, in such an Inquiry.

I am a past resident of the Cornwall area, who worked in Cornwall. I am an individual who is not a victim or survivor of sexual abuse, but, an individual who has supported the truth being disclosed surrounding this matter and the application of appropriate and “just” consequences; DARE ANYONE SPEAK OUT!! Do I trust the “system” in this matter.....does anyone? Following, are **some** of the consequences, I have experienced, relating to my, “speaking out”.

In the early 1990's, I believed many articles and editorials published in the Cornwall daily newspaper, chastised and vilified citizens for alleging sexual abuse and alleging cover-up. In my effort to encourage letters-to-the-editor, from a variety of perspectives, or to speak for those who could not speak for themselves or were afraid to speak out, I engaged in a "letter-to-the-editor" campaign. Consequently, lawyer's, for the parent company of the local daily newspaper, began vetting my letters-to-the editor; in some cases my letters were edited and modified beyond recognition, drastically altering their original theme. On one occasion, the parent company lawyer in Toronto communicated with me, advising me that a letter had been approved, but it was too late to publish and instead, the newspaper decided to print letters with "local" perspectives. On another occasion, an angry journalist for the same local daily newspaper telephoned me at my home, vigorously asserting, I should immediately retain a lawyer and therefore, implying, he was going to sue me. HOW DARE ANYONE SPEAK OUT!!

In addition, one of the accused advised me that I should shut-up. He stated that the "powers that be" in Cornwall were sick and tired of my letters and comments; he stated that I would not last long in the Cornwall Area. Shortly thereafter, an acquaintance of an accused approached me for discussion, informing me that some of the accused were member's of a group which was, "above the law" and they were so "privileged", they referred to themselves as, "The Untouchables". Furthermore, the "acquaintance" stated directly to me, that I should watch my step, because "The Untouchables" will kill, they have killed before and others who have spoken out against them, have been seriously harmed. I took the statement as a threat. HOW DARE ANYONE SPEAK OUT!!

Furthermore, Cornwall Area Priests filed, what I understand to be an unlawful and harassing, defamation-civil litigation, against me. The Priests were seeking millions of dollars in damages. In addition to other assertions I have, I believe this litigation was filed with the sole intention of silencing me, bankrupting me, harassing me and intimidating me. In this bogus litigation, I asserted the Priests failed to follow and respect the applicable, Ontario Rules of Civil Procedure and related, Rules of Court. After three years and in self-representation, this litigation was dismissed and I was awarded costs/disbursements. HOW DARE ANYONE SPEAK OUT!!

AND, a previous Ontario Attorney General wrote to me stating my comments and related information was causing citizen's to have a lack of faith in the Justice System.

I believe, individuals, including some journalists, have been ostracized and blacklisted, as a consequence of their attempts to secure "Project Truth and related" "facts", through "Access To Information" requests. I believe all requests were denied or interventions by other Justices or their representatives, resulted in the requests being denied.

Regarding this matter, former Ontario MPP Gary Guzzo and others, have implied, deception and cover-up, "GOES TO THE TOP"....including, every nook and cranny along the way.

It is not my voice or the voice of people like me, who have caused citizen's to have less faith in the justice system. I submit; examples such as the one's I have discussed herein, are what have caused, the lack of faith; it is the acts and acts of omission, "Project Truth and related" has endured, since Day-One; it has been the arrogant, dismissive-type, behaviours, such as the one displayed by Judge Glaude, which has caused the lack of faith. These are also, signs and symptoms, that "abuse" is present.
